# This Past Year - Highlights

#### Water Quality:

- Engaged Riverstone to do a review of Hamer Bay water testing results.
- Continued testing in Hamer Bay. 2020 MLA water testing, and Benthic testing cancelled

#### **Municipal Engagement:**

- Ongoing input to Seguin Council incl: Zoning issues, Official Plan Review
- Participation in the Seguin Lake Associations meeting this June
- Representing LJNA at FOCA Fall & Spring Meetings & AGM

#### Safety and Boating

- Hamer Bay Good Neighbours initiative continuing
- Investigated Fireboat Initiative and New Emergency Contacts sheet
- Joined Safe Quiet Lakes' Decibel Coalition

#### Community

- Increased eblasts this spring-in response to Covid
- Membership Survey to gauge membership's priorities
- Summer 2020 Newsletter and dockdrop 475 copies delivered



### 2020 Survey – Key Findings 208 responses....Thank you!

The Boards work:

- Strong vote of confidence: 33% Satisfied and 60% Very Satisfied
- Stewardship and municipal issues are seen as central roles of LJNA. Increase priority on all stewardship activities & civic engagement especially monitoring rezoning applications (70%).
- Higher priority to community safety (55%), safe boating (60%), fair taxes (57%), stewardship education (62%)
- General satisfaction with level of communications and community activities.

#### **Enjoyable Lake Experience:**

- Water quality and healthy environment are seen as important and good
- Lower ratings for safe boating & swimming, dark skies, balanced development, cell phone & internet
- Comments throughout: PWC's, lights at night, boat speed and noise, boat wakes, development.

# Goals for the coming year

- Bring a Fireboat to Lake Joseph
- Provide input to the Official Plan Review
- Improve Boating Safety signage in key locations
- Continue to
  - Provide input to key municipal decisions: OP Review, Short Term Rentals, LPAT appeal. ZBA applications,...
  - Build our community and our communications. Build membership.
  - Monitor water quality and launch a Benthic testing program.



# LPAT Appeal

- Recently, we began an appeal to LPAT of a zoning bylaw amendment approval by Council
- Factors in our Decision:
  - ZBA not supported by Seguin's professional planning staff many significant exemptions required from OP and By-laws
  - Undersized lot: the entire project is within the 30m shoreline setback. Does not protect the natural character of our shorelines
  - Previously refused at Council
- Next step: Report from professional planner
- The estimated total cost is \$25,000.



## A Fireboat for Lake Joseph

At the 2019 AGM we had overwhelming support to bring a Fireboat to LJNA. We have launched the campaign to make this dream a reality!

We need to raise \$150.000 to buy the boat and retrofit it with First Response equipment. Seguin Township will cover on going costs and maintenance


Once the boat is purchased it will be housed at Gordon Bay Marine





# **Municipal Update**

## Introduction

- LJNA represents the interest of shoreline residents on the Seguin Twp section of Lake Joseph and Portage Lake
- Most of LJNA is in Ward 4 but some are in Ward 3
- Municipal matters are an important part of LJNA's mandate. We advocate for fair taxes and reasonable development, and bring a voice to Council on issues that matter to our members.



## This Past Year

- Submissions on multiple key zoning by-law applications
- Retained planning consultant to support OP review
- Secured role on OP steering committee
- Submitted discussion paper on key issues to OP review process
- Retained lawyer and planning consultant to support the appeal of a ZBA



## What Is An Official Plan?

- A municipal policy document that guides decisions on land use and development and is implemented by the Zoning By-Law
- It sets out the vision, goals, and objectives for the municipality, and provides broad direction on matters such as growth management, infrastructure, protecting natural resources, employment lands, housing, natural hazards, parks, and the public realm.
- Must be consistent with the Provincial Policy Statement and other provincial plans and strategies.
- Outlines land use designations and policies, and maps out a land use structure across the Township.



## **OP Review Background**

- Current OP is 15 years old LJNA significantly involved
- Subject to review every 5 years
- Generally considered to be a "good plan"
- Steering committee formed comprising elected leaders, town planning staff, and community reps (incl. Tom Enns and James Buchanan)
- LJNA's primary focus is on the Shoreline Area



# **Recreational Carrying Capacity**

- RCC sets guidelines for density of recreational use on the water and is a very important tool for evaluating new shoreline lot creation
- Current policy structure may be inadequate for larger lakes
  - does not recognize density differences
  - does not address increased usage levels and impacts
- Recommend reassessment of standards and potential "neighborhood" approach



# **Boating Impact**

- Current plan does not require assessment of boating impacts in planning applications
  - Limited conditions for approvals for small lakes

 Recommend this is explicit especially for large lakes and expansion of commercial uses and new marinas



# Blasting Current OP does not permit blasting in the Shoreline Area 2008 by-law prohibits blasting with 20 m of shoreline • Shoreline area much greater than 20 m • Recommend review of blasting policies in order to ensure preservation of the natural state and address emerging issues

## **Character Provisions**

- Current plan deals explicitly with the character of development in the Shoreline Area:
  - Lot frontages, coverage and scale
  - Dock and boathouse policies
- Recommend review of current standards in the context of emerging issues:
  - Accessory buildings
  - Second dwellings/guest cabins
  - Waterfront structures



## **Other Issues**

- Process for consultation
- Uses permissions
- Short-term rentals
- Floating cottages and RV's
- Telecom towers



### **The Problem**

#### **Excessive boat noise is a persistent and pervasive** problem on Canadian waterways

- Bigger, faster more powerful racing boats are becoming common place on ۲ Canadian inland waterways
- Muskoka, Lake Simcoe, Big Rideau Lake, Okanagan and Shuswap in BC, • Memphremagog in Quebec and others
- 67% want muffler laws enforced, 61% want decibel legislation (SQL 2017 survey of ٠ 3,300)
- How Much is Too Much? > 75 dB on shore causes disruption of • conversation, shoreline residents become annoyed – take action

## Progress to Date Cont'd

- Significant knowledge accumulation
  - US/EU legislation, science of sound & measurements, muffler systems and mitigation options
- History of Small Vessel Act
- Developed Logo
- Identified Ottawa based lobbyist
- Purchased professional grade SPL (dB) meter
- Performed decibel readings on high performance boats
- Developing communication plan







### **Muffler Information Card**

#### Noisy boats bothering you? The law is on your side.

#### FACT

By law, marine mufflers are required on all boats manufactured after January 1, 1960. (Small Vessel Regulations SOR/2010-91)

#### FACT

By law, boats with a exhaust diverter (aka Captain's Call, Silent Choice, Captain's Choice) must be visibly disconnected in a manner that ensures it cannot be easily reconnected while the vessel is in operation within five nautical miles from shore (that's anywhere on our lakes).

Excessive boat noise is the number one concern expressed in our cottager surveys and we mean to do something about it. Safe Quiet Lakes is working to strengthen legislation to include decibel limits that are easily enforced.

#### Give your Neighbours the Silent Treatment.

If your boat is not legal, please see your marina, mechanic or dealer to have the Exhaust Diverter disconnected or a muffler installed.

#### How do I know if my boat is legal?

The vast majority of boats on our lakes comply with the law. These include all boats where the engine exhaust exits through the propeller including all outboards, most inboard/outboards, all personal watercraft and most wake-board boats that have the exhaust exiting below the waterline.

What can I do if my boat is not legal?

Having the Exhaust Diverter disconnected is usually a simple process that can be done by your mechanic for a nominal cost. Various muffler solutions are available in the market place for boats that currently do not have a muffler. Costs start as low as a few hundred dollars. In the case of extreme high performance racing boats there may be no option. Failure to comply with these regulations could result in a fine under the Canada Shipping Act 2001.

The OPP wants to hear from the community about dangerous or aggressive boating.
